

# AGREEMENT ON COOPERATION

between

**State Budgetary Institution of Further Professional Education «Stavropol Regional Institute for Advanced Studies of Educators», Russian Federation**

and

**Regional Centre of Retraining and Professional Development of Educators at the University of Namangan, Republic of Uzbekistan**

Stavropol Regional Institute for Advanced Studies of Educators (the Russian Federation, City of Stavropol), established in accordance with the current legislation of the Russian Federation, represented by Elena Vladimirovna Evmeneko, Rector, acting on the Charter, and Regional Centre of Retraining and Professional Development of Educators at the University of Namangan (the Republic of Uzbekistan, City of Namangan), established in accordance with the current legislation of the Republic of Uzbekistan, represented by Ilhom Abdullaevich Rahimov, Director, affirming their interests in establishing cooperation in education, technology and science, have agreed as follows:

## Paragraph 1

The subject matter of the Agreement is to establish purpose and period of cooperation between the institutions.

## Paragraph 2

It is expected the exchange of lecturers and studies under the Agreement.

## Paragraph 3

The parties have agreed to cooperate in the following areas:

### **In exchange of lecturers:**

- The exchange of lecturers for research, seminars and lecturing.
- The exchange of experience in methods of teaching.

### **In research:**

- Cooperative research projects implementation in areas of mutual interest.
- The exchange of scientific and methodological information.
- Coordination of research.
- The exchange of research findings in areas agreed between the parties.
- The publication of research results in these areas is under the conditions prescribed by the Cooperation Plan which is attached to this Agreement.
- Organization of joint seminars, conferences, symposiums, etc.

## Paragraph 4

With a view to achieving the purpose of the Agreement, the Cooperation Plan will be drawn up. The Cooperation plan will be an Annex to the Agreement.

## Paragraph 5

The institutions agree to make necessary efforts, whenever possible, to provide sufficient funding to implement the provisions of the Agreement.

Paragraph 6

1. The institutions will send up the lecturers in accordance with current provisions which are in force in every institution.
2. Precise timing, in particular, the periods and the duration of stay of representatives of the institutions will be specified in the Annex, referred to in paragraph 4 of the Agreement.

Paragraph 7

1. All disputes and differences that may arise out of present Agreement are to be solved by friendly negotiations.
2. The institutions are not allowed to transmit the rights and responsibilities under this Agreement.
3. The Agreement shall be effective for three years.
4. This Agreement comes in force upon its signing by the parties.
5. Each Party may terminate this Agreement on giving 6 months' notice in writing to the other Party.
6. Any changes or supplements to this Agreement shall be made in writing and require written consent from the institutions.

Paragraph 8

1. This Agreement is made in Russian and English language in duplicate having equal legal force and effect, one for each party.
2. In the event of any ambiguity, the English version shall prevail.
